Be organized, review transcript before meeting with advisee, give timely feedback (for example, reply to a phone call message within 24 to 48 hours), and meet with advisee in person."

## Spring Supplemental Instruction (SI) – Another program to enhance

student success!

The POWER Center (TRiO Student Support Services), along with the Center for Engaged Teaching and Learning (CETL) are currently providing sections of Supplemental Instruction (SI) for the spring 2012 semester. Unlike other forms of assistance, SI targets high risk courses rather than high risk students. ALL students are encouraged to attend SI sessions because the courses being targeted have shown to have historically high D/F/W rates for a large number of Minot State University students. The ultimate goal is to provide every individual in the targeted course the opportunity to develop proper study skills, learn material with and through peers, and go beyond the lectures to focus on content relevancy. SI will not replace classroom instruction. Students will still be expected to attend every class session, take notes, and actively participate in class discussions. SI teaches students how to learn while teaching them what to learn. Instead of teaching students study skills in isolation from content material, SI sessions are focused

on using study strategies during sessions. Students are then able to transfer those learning capabilities to other disciplines.

SI is an academic assistance program that utilizes peer-assisted study sessions. SI sessions are regularly-scheduled, informal review sessions in which students compare notes, discuss readings, develop organizational tools, and predict test items. Students learn how to integrate course content and study skills while working together. The sessions are facilitated by SI leaders; students who have previously done well in the course and who attend many class lectures, take notes, and help students meet the expectations for the course.

Research validated by the U.S. Department of Education shows that students who participate in SI earn higher final course grades, withdraw at a lower rate, and also persist at a higher rate than students who do not attend SI.

## **Early Alert**

The Early Alert Program provides assistance to students experiencing academic and/or behavioral difficulties. With the success of last term's early reporting for the pilot group, reporting is being expanded to all students. We are requesting assistance in reporting any student academic or behavioral concerns you have observed.

Early Alert reports are defined as occurring within the first four weeks of coursework. However, this link will remain available at all times, so feel free to utilize it any time you are concerned. On any given day, any student could be at risk.

Faculty awareness of potential problems constitutes the backbone of the Early Alert Program. To report any concerns, go http://www.minotstateu.edu/faculty.shtml (Faculty and Staff webpage) and click on Early Alert Program.

Approximately the fifth week into the term, the POWER and/or Student Success Center will request feedback on specific students similar to what occurred fall 2011 with the pilot group.

Early Alert reporting does not replace the mandatory attendance reporting required by NDUS policy. In addition,

### **Limitations on Transcript Credit**

Religion Course Credit - No more than six semester credits in doctrinal religion will be accepted in transfer. Doctrinal religion courses that are accepted can be used as electives only.

## Resource of the Month – Student Government and Student Activities

The transition from high school to college or even from another college is never easy. One positive way for students to feel more at ease is to find a "sense of place" here at Minot State University. Getting engaged in campus life is one of the easiest ways to find that sense of belonging.

The Minot State Student Government Association is responsible for establishing a student government that promotes the general welfare of the students as well as increasing student involvement through the Student Activities Committee (SAC). The goal of SAC is to ensure there is a sense of place for students. The Student Activities Committee works to provide a wide variety of campus entertainment. Activities include dances, musicians, comedians, free food, games and other speakers.

In conjunction with regularly scheduled entertainment activities, MSU After Dark hosts late night programming options. MSU After Dark is a late night programming initiative to provide alternative opportunities for students to engage in various evening entertainment activities. MSU After Dark events are most successful when clubs and organizations propose a program that will be entertain campus wide. Events are regularly held during later evening hours and typically occur on Thursday or Friday evenings. Events include fleece tie-blanket or other craft nights, speed dating, movie nights and glow in the dark games.

Lastly, if a student is interested in starting a club or organization on campus, has a proposal for an entertainment activity or simply wants to get involved with the planning committee for these events, have them stop by the Student Government Office! Whether a student is looking for a way to get involved in coordination of activities or wishes to just attend events—student activities will help fulfill that sense of place.
